

Information for Law Subject Specific Study Abroad in 2026-27

About Study Abroad

All students enrolled on a 4-year Honours degree are eligible to apply to study abroad in their 3rd year. Students on an Ordinary or General degree, lasting 2-3 years, are not eligible to apply to spend a year studying abroad.

Eligibility to Study Abroad

Students due to go abroad must have passed 240 credits by the end of 2nd year. August resits are not permitted to count towards this total according to University regulations. Only in certain circumstances can study abroad after failing any credits be permitted, valid exceptional circumstances and a concession would need to be in place for this to be considered. Please talk to your student advisor if you are interested in studying abroad and have concerns or queries about this.

Study and Work Away Service (SWAY) Information sessions

<u>Information sessions</u> are run centrally for students interested in applying to go on exchange, or who have a requirement to study abroad as part of their degree. These are aimed at 2nd year undergraduates and are centrally arranged by the Study and Work Away Service. Please also refer to the information on <u>key things to consider</u>.

Funding

Funding is an important consideration when thinking about applying to study abroad. Further guidance on estimated living costs can be found against each available destination in this guidance document.

The University is prioritises financial support for students required to undertake work and study abroad as a mandatory requirement of their degree programme. Eligible students going on semester or year-long exchanges and placements can expect to receive between £336 and £532 per month, depending on their destination. The Turing grant is intended to help towards travel expenses and the cost of living abroad – it is not intended to cover all costs. Additional funding is available to students from disadvantaged backgrounds, and those with special educational needs or disabilities.

Global Law LLB Programme

Students on a Global Law degree have a compulsory 3rd year abroad, as required by their programme. There are a number of specially selected host institutions available to Global Law students, in order to satisfy the requirement of the Global Law degree whilst studying abroad. Further details can be found in the table in this guidance document, and on the Study Abroad section of the current student website.

Law LLB Hons Programme

Students on the Law Hons degree have the option to study abroad in 3rd year. There are a wide range of host institutions available to choose from, further details can be found in the table in this guidance document, and on the Study Abroad section of the current student website.

Law and Language Programmes

Students on a Law and Language degree have a compulsory 3rd year abroad, as required by their programme. There are a limited number of options available to students on these joint language degrees, as they must select an institution which teaches in the language they are studying to satisfy the language requirement of their degree whilst studying abroad. Full details of languages taught at Law School exchange institutions can be found in the table in this guidance document, and on the Study Abroad section of the current student website.

Joint Degrees

Students on a joint degree must ensure that they follow the same division of credit points across Law and their second subject area as specified for Year 3 in the Degree Programme Table for their degree. For example, students normally required to enrol in 40 credits of law and 80 credits of a second subject area must ensure they keep the same general 1/3 to 2/3 split on their year abroad.

Students must also liaise with the Law School Exchange Coordinator Longjie.lu@ed.ac.uk and the partner subject School to check there is sufficient and suitable course provision at their preferred institution to meet the requirements of their 2nd named subject area. As some exchange partners are Law School specific, they may not be suitable for students who are studying on a multidisciplinary degree, for example, Hong Kong. This includes students on the International Relations and International Law (MA).

Non-Law and Language Studying at Mixed Language Institutions

Students who are not studying a language degree, but opt to study at a mixed language institution (full details below) are responsible for checking adequate course provision in English before applying to study at the preferred institution. It should also be noted that students will be subject to a language test and must achieve at least a B2 in the relevant language of the host institution.

The Application/Allocation Process

Applications are made via Mobility Online between 29th October (12 noon) and 12th November 2025 (12 noon). Further information regarding the application process, and the associated guidance and timescales can be found here.

All students will have the option to provide a personal statement to support their application. Please note that this is optional for all Law students, including Global Law students.

Please note that the Law School only administers our own subject-specific exchanges, and the university-wide exchanges are NOT available to School of Law Students.

After applications close, students are initially allocated to a preferred destination according to Year 1 credit-weighted average.

Once students are successfully allocated a place to study abroad, it is compulsory that you attend a pre-departure session which will be run by SWAY.

Learning Agreements and Course Requirements

Once you have completed your Learning Agreement, you should email it to Longjie.lu@ed.ac.uk to have it signed off by the Law School exchange coordinator. Students on other joint degree programmes must also have it signed off by the exchange coordinator in the partner-subject School.

Advanced Legal Writing (Online)

All programmes require Advanced Legal Writing in Year 3, students must **PASS** Advanced Legal Writing (Online) whilst studying abroad. This course is completed via online learning, and materials and assessment are handled via its own LEARN page. Advanced Legal Writing (Online) is worth 10 Edinburgh credits, which translates

into 5 ECTS (or the equivalent). The standard load whilst studying abroad is 120 credits, which is 60 ECTS (or the equivalent). As Advanced Legal Writing (Online) is included as part of the overall study abroad load, this is why the credits required abroad (as detailed above) are less than 60 ECTS.

Studying Law in Context

This is an optional course usually only available for Law and Language students who need to address a credit shortfall at the host institution. Studying Law in context is worth 20 Edinburgh credits, which translates to 10 ECTS (or the equivalent), and is also completed via distance learning with materials and assessment delivered via its own LEARN page. It is designed to complement their course credits by taking a full-year course culminating in the completion of a comparative and reflective essay on a selected topic of the legal system in which the exchange is taking place. The essay and course guidance are in English.

Studying Abroad

It is extremely important that you check your Edinburgh University email account regularly. You will also be expected to keep up with materials and any assessments via the Advanced Legal Writing (Online) LEARN page, similarly for Studying Law in Context (if taken). You will also receive important information about course selection for your final year of study, as well as dissertation topic selection.

Contacts whilst Studying Away

You can contact Law.Exchanges@ed.ac.uk, monitored by the Study Abroad team, at any time during your studies abroad for assistance. You will still have access to your Student Adviser for any pastoral support during your study abroad, who you can also proactively contact via email: Law.SSO@ed.ac.uk

University Engagement Monitoring Requirements

You will be contacted at regular intervals throughout the year as part of the University's obligation to monitor the engagement of all students, even those who are studying away. It is important that you respond to messages of this nature to avoid any cause for concern.

Returning from Study Abroad

Course Selection - Year 4

You will be contacted by the Undergraduate Office in Semester 2 of your year abroad regarding course selection for studying in Year 4. Remember that you are unable to take courses in fourth year which have a substantial overlap with courses you have taken abroad. When thinking about your choices following your return, if you are in doubt about an overlap, contact the course organiser of the Edinburgh course with course outlines of the courses you are studying abroad. Full guidance regarding course availability and how to make your selections will be sent to your University email address. Honours course spaces are allocated on the basis of credit weighted average. For students returning from study abroad, your credit weighted average will be calculated using your results from Year 1 and 2, plus an additional percentage increase of at least 4% which reflects the average increase in grades between students from Ordinary to Honours.

Dissertation Information

You will also receive information regarding the Dissertation in Law topic selection (if required by your degree programme) in Semester 2 of your year abroad. The Dissertation topic should be chosen from a subject studied in 3rd year – this may also be useful to bear in mind when making course choices abroad, though additional flexibility is given to students who have spent their 3rd year abroad.

Progression to Year 4

The College Study Abroad Progression Committee meets in early-mid September to make progression decisions based on transcripts received from host institutions.

Transcripts

Student must be aware that there can sometimes be delay in the receipt of transcripts from the host institution. Where this occurs, progression decisions will be deferred. Student who know they have passed their year abroad courses can still progress onto Year 4, and the formal decision to 'progress' will be updated once a transcript has been received. Students who have any concerns about their year abroad results are encouraged to contact law.sso@ed.ac.uk.

Study Abroad and Degree Classification

Students should note that classifications following study abroad are based solely on performance in Year 4. This is with the exception of Law and Language degrees. Further details on how Law and Language degree classifications are calculated can be found on the relevant <u>DPT</u>.
